The Chairperson read the following opening statement before convening the meeting:

"This Committee meeting has been called to discuss the items of mutual interest and concern to the members of the Wisconsin Compensation Rating Bureau. In accordance with both Federal and Wisconsin State Anti-trust Laws, this Committee is prohibited from any discussion or action which constitutes any form of boycott, coercion or intimidation."

This Special Governing Committee meeting was called to discuss the following items:

- 1. Dr. Richard Victor, Director of the Worker's Compensation Research Institute presented a summary of the Multistate Benchmarking Report. The final draft of the report has been delayed and will be available for distribution in early Fall.
- 2. President Herrmann addressed the outstanding motion regarding data collection. After discussion, the Committee adopted the recommendation to give member carriers the option to file Unit Statistical cards either directly with the Bureau or with the NCCI.
