ITEM NUMBER 3783 NCCI PROPOSAL ITEM B-1351 WORKERS COMPENSATION PREMIUM ALGORITHM

The current premium algorithm has the application of the Wavier of Subrogation factor being applied prior to the application of the experience modification. Since the Wavier of Subrogation factor is a flat charge, the Committee concurred with the recommendation to reposition the application.

ITEM NUMBER 3799 CORPORATE OFFICER NON-ELECTION OF COVERAGE AND ITS EFFECT ON PREMIUM COLLECTION FOR CLAIMS ARISING UNDER THE JONES ACT AND LONGSHORE AND HARBOR ACT

Bureau Legal Counsel, Paul Riegel, advised that the WC Advisory Council is not taking action on this item at this time. This item is removed from the agenda.

ITEM NUMBER 3817 IMPLIED EMPLOYMENT RULE

Bureau Legal Counsel, Paul Riegel, advised that the WC Advisory Council is not taking action on this item at this time. The Committee concurred that the audit departments of member carriers should make the determination on the application of Implied Employment Rule. This item is removed from the agenda.

ITEM NUMBER 3823 HONTHANERS V LIRC

The Committee was advised that the impact the Honthaner v LIRC decision will have on the rates is not known at this time. The potential impact will continue to be assessed.

ITEM NUMBER 3826 HARTFORD FORM FILING

After discussion, the Committee voted to adopt the proposed Insured's Name and Address Linking Endorsement as submitted by Hartford Insurance Group for filing with the Office of the Commissioner of Insurance for approval.

ITEM NUMBER 3827 NCCI PROPOSAL ITEM B-1369 2001 BASIC MANUAL FOR WORKERS COMPENSATION AND EMPLOYERS LIABILITY INSURANCE

The Committee voted to file the proposed revised Basic Manual with the Office of the Commissioner of Insurance.

The proposed amendments to the Wisconsin Exception Pages to the Basic Manual contained revisions to the current cancellation provisions. The cancellation provisions will be removed from the proposed pages and the remaining Exceptions will be filed with the Office of the Commissioner of Insurance for approval.

ITEM NUMBER 3828 NCCI PROPOSAL ITEM R-1371 – 2001 UPDATE TO RETROSPECTIVE RATING PLAN PARAMETERS

The Committee voted to adopt the proposed 2001 Update to Retrospective Rating Plan Parameters. This item is proposed to be effective July 1, 2001, applicable to new and renewal business only.

ITEM NUMBER 3829 REGAL LIMOUSINE SERVICE – HEARING

By the unanimous consent, this item was added to the agenda.

On May 18, the Rating Committee denied a petition submitted by Regal Limousine Service to reclassify their operations from code 7370 Non-Schedule Limousine Company to 7382 Limousine Company – Scheduled. The WCRB was directed to investigate whether code 7370 was a suitable code for limousine services. The Committee agreed with the recommendation of the WCRB to assign limousine companies to class code 7380 rather than 7370. This change in interpretation is effective July 1, 2001, applicable to new and renewal business only.
