The Chairperson read the following opening statement before convening the meeting:

"This Committee meeting has been called to discuss the items of mutual interest and concern to the members of the Wisconsin Compensation Rating Bureau. In accordance with both Federal and Wisconsin State Anti-trust Laws, this Committee is prohibited from any discussion or action which constitutes any form of boycott, coercion or intimidation."

UNFINISHED BUSINESS

ITEM NUMBER 3748 CONTRACTOR PREMIUM ADJUSTMENT PROGRAM

The Committee was provided with the usual update on WCPAP activity.

The Committee also was advised that the program sunsets on July 1, 2004. The Committee discussed possible options available and a preliminary review conducted by Milliman USA. The WCRB will form a work group to address the issues.

ITEM NUMBER 3839 TERRORISM/CATASTROPHE ISSUES

The Committee discussed the study facilitated by the AIA exploring the possibility of a voluntary pooling arrangement with carriers. No consensus has been reached.

The WCRB was directed to determine the filing requirements for continuing the current TRIA filing.

ITEM NUMBER 3842 LARGE DEDUCTIBLE PROGRAM

Each member of the Committee was furnished with a copy of a proposed Loss Reimbursement Program submitted by Liberty/Wausau. Discussion centered on several outstanding issues that have not been addressed such as the impact on the Guarantee Fund, side agreements, law changes, and changes to cancellation provisions. This item is continued.

ITEM NUMBER 3843 OCI MARKET CONDUCT EXAMINATION

The Committee was advised that the premium discount issue is still outstanding and the WCRB is waiting for a response to a letter from legal counsel. The Committee requested an actuarial analysis of the performance of the assigned risk business versus the voluntary business. This item is continued.

ITEM NUMBER 3849 NCCI PROPOSAL ITEM U-1396 – URE WCSP PENSION TABLE REVISIONS (1999 MORTALITY)

The Committee adopted the update to the current URE WCSP Pension Tables. This filing will be proposed to be effective with losses valued as of July 1, 2004.

ITEM NUMBER 3850 NCCI PROPOSAL ITEM E-1379 – 2003 EXPERIENCE RATING PLAN MANUAL FOR WORKERS COMPENSATION AND EMPLOYERS LIABILITY

The Committee was advised that several WI exceptions would have to be created if the proposed revised manual were to be filed. The Committee concurred with the recommendation of the WCRB not to adopt this proposal and proceed with the development of a WI Experience Rating Manual.

President Herrmann expressed his appreciation for Sentry's hospitality and for hosting this meeting.
