UNFINISHED BUSINESS

ITEM NUMBER 3748 CONTRACTOR PREMIUM ADJUSTMENT PROGRAM

Tad Cleveland provided an update of the Wisconsin Contractor's Premium Adjustment Credit Program. For the latest WCPAP period, beginning July 1, 2005, the WCRB has mailed 24,157 applications. This number represents all policies containing a contracting classification with an effective date July through December. The resulting average credit of 4% comes from 5,207 applications processed with effective dates July through March.

The Committee also was reminded that the program sunsets on July 1, 2007. A preliminary review will be prepared by Milliman Inc.

ITEM NUMBER 3852 WWCIP SURPLUS REPORT

This item is continued as a reminder to provide an update in December.

WCRB will continue to monitor Pool activity and may provide additional information prior to the December meeting.

ITEM NUMBER 3870 NCCI PROPOSAL ITEM B-1393 MISCELLANEOUS VALUES FOR DOMESTIC TERRORISM, EARTHQUAKES, AND CATASTROPHIC INDUSTRIAL ACCIDENTS

The Committee reaffirmed their e-mail votes to file amendments to TRIA and DTEC as proposed by the NCCI Item P-1404 – Terrorism Risk Insurance Extension Act of 2005.

The Committee was furnished with an update of the results of the questionnaire sent out to member companies asking what each carrier is charging for TRIA, DTEC, installment fees, what premium discount table is being used and if the short-rate cancellation penalty is being applied. The summary is available to member companies upon request.

ITEM NUMBER 3875 PROFESSIONAL EMPLOYER ORGANIZATIONS (PEOs)

The Committee was furnished with a copy of a letter from the Office of the Commissioner of Insurance extending the review of the proposed Basic Manual Rule relating to PEOs to June 1, 2006. The Committee was also given a copy of proposed Assembly Bill 1056 proposing regulation of the PEO industry, as well as a proposal from the state of Georgia.

ITEM NUMBER 3880 MECHANIZED LOGGING

The Committee was furnished with a copy of proposed Assembly Bill 686. This Bill would permit two or more logging employers to group together to self-insure their worker's compensation liabilities and establish a separate classification for mechanized operations. The Bill has been referred to the Forestry subcommittee and has not been introduced on the floor of the Assembly.

The establishment of class code 2709 - Logging or Lumbering – Mechanized Equipment Operations & Drivers has been approved effective October 1, 2006.

ITEM NUMBER 3863 NCCI PROPOSAL ITEM B-1387 – REVISIONS OF BASIC MANUAL CLASSIFICATIONS

The Committee reaffirmed their e-mail vote to withdraw class code 8864 Social Service Organization – All Employees & Salespersons, Drivers and retain code 8842 Group Homes – all Employees & Salespersons & Drivers. Entities previously classified under code 8837 or 8864 will be assigned the classification(s) that best describes the business of the employer.

ITEM NUMBER 3883 SKIL-TECH, INC.

Skil-Tech, Inc. has appealed the December 6, 2005 Rating Committee decision determining that there was no requirement under either the NCCI Experience Rating Plan Manual or the Unit Statistical Plan Manual for West Bend Mutual Insurance Company to file a correction report on the 1997 claim. A hearing before the Office of the Commissioner of Insurance is scheduled for March 23, 2006.
