NEW BUSINESS

- ITEM R-1414-B—Revisions to Retrospective Rating Plan Manual Appendix B and All Related Rules and Endorsements – this item proposes an amendment to filed and approved Item R-1414 providing revisions to the methodology and table lookups in the Retrospective Rating Plan Manual. The Committee voted to approve filing the item with the Office of the Commissioner of Insurance with an effective date upon approval. This item continues on the agenda.
- ITEM P-1418—Revisions to Catastrophe (Other Than Certified Acts of Terrorism Premium Endorsement- this item revises the definition of Catastrophe in the Catastrophe (Other Than Certified Acts of Terrorism) Premium Endorsement. The Committee voted to approve filing the item with the Office of the Commissioner of Insurance with an effective date of 08/01/2022. This item continues on the agenda.
- Estimated USR Fining Proposal general discussion of a WCRB proposal to include Estimated USR letters in the established fining procedure promulgated in the Unit Statistical Plan Manual. The Committee voted to approve filing these changes with the Office of the Commissioner of Insurance with an effective date of 4/01/2022. This item continues on the agenda.

The Board voted to levy an assessment in the amount of \$2,064,380 for the general operating expenses for the WCRB for the fourth quarter of 2021.

B. Administrative affairs, occupancy, general expenses, personnel, etc. The Board was updated on several items:

- Chris Reader, the Governor's appointee to the Governing Board and Rating Committee, resigned his position. A request has been sent to the Governor's office to appoint a replacement.
- The WCRB office will remain work-from-home with all staff reporting in person every other Wednesday with full COIVD precautions.
- The WWCIP servicing carrier audits will move from scheduled annually to a targeted, as needed basis.
- Legislative Update general discussion among the Board over pending and potential upcoming legislative issues.
- WC Hearings/OWCH- general discussion on a proposal to reinstitute preliminary hearing requirements. This item continues on the agenda.
- WWCIP Activity The usual Pool activity reports were provided.

All votes taken at the Rating Committee and Governing Board meetings were unanimous unless otherwise noted.
